As we reflect on the past year, we are reminded of the urgent realities faced by children and adolescents in vulnerable communities. The ripple effects of food insecurity, economic hardship, and mental health challenges continue to shape their daily lives. Yet, through adversity, we rest knowing that the power of community and collaboration will continue to support our drive for resilience.

In 2024, Lluvia Health took significant strides in addressing childhood malnutrition and mental health. Our food distribution program reached hundreds of vulnerable families, particularly young mothers and caregivers of children under 5yrs in urban slums, ensuring that those most at risk had access to food items for nutritious meals.

We also launched our Play and Thrive Project, an innovative project that integrates therapeutic play into pediatric healthcare for mental health promotion and protection. Our pilot hospital playroom at Gbagada General Hospital provides a safe space where hospitalized children and children with chronic health conditions can socialize, express themselves, learn, and find joy even as they navigate difficult health challenges. Through co-creation with children, parents, healthcare professionals, and government agencies, we developed a replicable framework to bring play-based psychosocial support to paediatric healthcare in Nigeria.

None of these achievements would be possible without our dedicated partners, donors, and community members who share our vision of a world where every child can thrive, regardless of their circumstances. As we look to 2025, we plan to strengthen our nutrition program by including economic empowerment for young mothers, ensuring that families have sustainable pathways out of poverty and food insecurity. We know that when mothers thrive their children have a better chance at growing up healthy, nourished, and emotionally secure. We also will be expanding our therapeutic play program to more hospitals and communities.

The road ahead remains challenging, but with your support, we are determined to expand our impact-strengthening nutrition, advancing mental health care, and making play an essential part of childhood for all.

Thank you for going along with us on this journey. Together, we will help children be healthy, happy, and confident.

CHILD NUTRITION: FOOD DISTRIBUTION **PROJECT**

DELIVERING ESSENTIAL FOOD SUPPLIES TO THOSE WHO NEED IT MOST





This year, Lluvia Health Organisation provided hope and nourishment to vulnerable families through its annual food distribution project targeted at pregnant women, Young mums aged 15-24 years, and caregivers of children under 5 at Alimosho and Lagos Island suburbs of Lagos.

On December 21, 2024, Lluvia Health Organisation brought hope and nourishment to vulnerable families through its annual food drive, held at Ikotun Primary Health Centre in Alimosho LGA and Iga Iduganran Primary Health Centre in Lagos Island LGA. The drive was more than just a distribution—it was a day of support, empowerment, and community bonding, ensuring that families, especially young and their children had access to nutritious food and the mother provided essential health knowledge.

Each family received food supplies that provided much-needed relief in the face of rising food prices. Beyond the food distribution, health educators at both locations led vital discussions on Maternal, Infant, and Young Child Nutrition (MIYCN), antenatal care, hygiene, and overall wellbeing, equipping families with the knowledge to make healthier choices for their children. At Ikotun PHC, the atmosphere was even more lively with interactive games that fostered connections and brought smiles to the participants.

CHILD NUTRITION

A TOTAL OF 1,899 INDIVIDUALS ACROSS 404 FAMILIES BENEFITTED FROM THE INITIATIVE— 210 FAMILIES AT IKOTUN PHC AND 196 FAMILIES AT IGA IDUGANRAN PHC. AMONG THEM, 156(38%) WERE YOUNG MOTHERS AGED 15 TO 24, WHILE 248(61%) WERE OLDER MOTHERS AND CAREGIVERS WITH CHILDREN UNDER FIVE.

This initiative was made possible through the generosity of individual donors and the invaluable product support from Golden Penny and Peak, whose contributions ensured that families had access to staple foods and essential nutrition. The impact of this food drive beyond numbers—it brought goes comfort, eased burdens, and reinforced the message that no family should have to struggle alone.

PLAY AND THRIVE





Our Play and Thrive Project funded by Bama Mayonnaise came to life! We are thrilled to share that we established our fully staffed and furnished pilot playroom at Gbagada General Hospital.

The playroom brings joy, comfort, and psychosocial support to hospitalised children and children with chronic health conditions including disabilities. This milestone is the result of months of collaboration, discussions, and careful planning to ensure that every child-regardless of their health conditionhas a space to play, express themselves, and heal.

We utilized a Human human-centred design approach, making sure the voices of stakeholders including children were captured. A template for the ideal hospital playroom was designed by Clinton Health Access Initiative (CHAI) in collaboration with representatives from government agencies such as LASUTH, Lagos State Ministry of Health, and Lagos State Health Service Commission; UNICEF, Nobelova, the Association for Play Therapy Nigeria (APTN), and the Children's Developmental Centre (CDC), parents and children, including children with disabilities to ensure inclusion

We believe that every child—regardless of their health status —deserves the chance to play, smile, and thrive. With the Play and Thrive Project, we are making play an essential part of paediatric care.





Elements of a hospital playroom:

"CHILDREN WITNESS WHAT HAPPENS WITH THE OTHER CHILDREN AS THEY ARE NOT SHIELDED FROM THE DEATHS OF OTHER CHILDREN ON THE WARD, AND OFTEN WITNESS RESUSCITATION ATTEMPTS. THIS CAN BE A FRIGHTENING EXPERIENCE AND HAVE A NEGATIVE IMPACT ON THEIR MENTAL WELL-BEING. Therapeutic Play Outreaches

Children in hospitals usually experience fear, isolation, and a loss of control. To provide emotional and mental health support, we hosted a Children's Day Play and Arts Event for hospitalised children at Lagos State University Teaching Hospital (LASUTH).

Children participated in a variety of activities such as building bricks, puzzles, painting, and pottery facilitated by volunteers. Children who couldn't leave their beds had books read to them by The Bookworm Café and volunteers. Parents weren't left out as they took the opportunity to participate and bond with their children even in difficult moments.







Raising awareness and advocating for play on the Inaugural United Nations International Day of Play



On June 11, 2024, the world celebrated the first-ever International Day of Play, as declared by the United Nations. To mark this historic occasion, Lluvia Health Organisation, in collaboration with Upbeat Recreation Centre, The Children's Arts Gallery (TCAG), and Bama Mayonnaise, organised an exciting play-centred event for children with chronic health conditions and children with disabilities from various foundations, including the Children Developmental Centre, Sickle Cell Foundation, Irede Foundation, Loving Gaze Foundation, and Dorcas Cancer Foundation, for a day filled with laughter, creativity, and movement.

We focused on the benefits of play in protecting and improving the mental health and well-being of children by providing positive experiences and emotional outlets through creative expressions. Children participated in vibrant art activities including painting, collage-making, and colouring, with each child receiving art supplies to maintain therapeutic arts activities.



Parents received group counselling and bonded with their children during play. With the Paediatric Association of Nigeria and the Ministry of Health present, we took the opportunity to advocate for playrooms in healthcare facilities, ensuring that every child, regardless of health challenges, experiences the benefits of play.

Mrs Oluwabi recounted that her children, Iremide, male, 6 years old and Iretomiwa, female, 4 years old, kept the drawings and even took them to school to show their classmates. She said her son has been drawing since then and has the drawings from the past event pasted on the walls. Iremide asked if they would like to participate in the activities again.





BUILDING THE WORKFORCE FOR PLAY INTERVENTIONS

Children with Disabilities are often stigmatized and excluded from play. The play component of the Build A World of Play Project, where Lluvia Health provides technical support to the Children's Developmental Centre, is reversing this. We co-facilitated a training program on Play interventions for children with disabilities, benefiting 100 healthcare workers and educators in the public sector. This training was conducted to build the capacity of healthcare workers and educators to provide play interventions for children with developmental delays, with the aim of providing inclusive play and achieving developmental milestones.

NOTE TO ACCOUNTS

1 GENERAL INFORMATION

Lluvia Health Organisation is a not-for-profit organization founded on improving the health and well-being of children and adolescents, creating positive healthcare experiences, and nurturing essential life skills. Our mission is to ensure that every young individual has the opportunity to grow and thrive, while equitably accessing quality health services, proper nutrition, meaningful play, and vital life skills for optimal health and overall well-being.

It commenced operation in 2020 but officially registered on the 14th December 2016 with Incorporation number IT 93300

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

2. The principal accounting policies adopted in the preparation of these annual financial statements are set out below. These policies will be consistently applied in the future and reported where changes occur.

BASIS OF PREPARATION

(a) The financial statements of Lluvia Health Organisationhave been prepared in accordance with International Financial Reporting Standards (IFRS) issued by the International Accounting Standards Board and IFRIC interpretations. These annual financial statements are presented in Naira and prepared under the historical cost convention with information and data provided by the owner of the NGO. The preparation of financial statements in conformity with IFRS requires the use of certain critical accounting estimates. It also requires directors/trustees to exercise their judgement in the process of applying the accounting policies.

(b) REVENUE RECOGNITION

Revenue of the NGO represents donations from the trustees, donations from private companies and dontions from various individuals in cash, kind and use of facility. The organisation recognises revenue when the amount of revenue can be reliably measured and when specific criteria have been met.

(c) RECEIVABLES

Members paid their dues timely and regularly, hence there is no reveivables in the accounts.

(d) PAYABLES Payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method. Payables are classified as current if they are due within one year or less. If not, they are presented as non-current liabilities. FUNDS

This is the accumulated earning over the periods of operations.

World Breastfeeding Week

During World Breastfeeding Week, Dr. Amenze Eguavoen, Executive Director, Lluvia Health, participated in radio rounds to advocate for breastfeeding and maternal nutrition, reinforcing our commitment to the Nutrition Pillar.

International Day of Play

On June 11, 2024, in celebration of the United Nations' inaugural International Day of Play, Lluvia Health participated in a webinar titled "The Importance of Play in Hospital Settings," hosted by the Association of Play Therapy Nigeria. This aimed at raising awareness on the health benefits of play in children and advocating for the integration of play as a therapeutic tool in healthcare environments.

We also leveraged VOP TV's "Health Talks" segment, to speak about the transformative benefits of play as a vital component of children's everyday emotional and mental development.

World Mental Health Day

In observance of World Mental Health Day, October 10, 2024, Lluvia Health hosted a webinar titled "Early Intervention: The Role of Play and Nutrition in Children's Mental Health." Featuring experts such as Philip Dimka, a psychologist, trauma therapist, and play therapy practitioner, and Temitope Fawehinmi, a registered dietitian. The session provided insights into our innovative approaches to mental health support.

A workshop targeting parents and caregivers at Gbagada General Hospital, titled "Play for Emotional Strength," was conducted by our Hospital Play Specialist/psychologist, Jennifer Odeniyi. The session equipped parents with tools to support their children's emotional development.
